# **Equipment Inspection Instructions and Timetable**

Equipment inspection for the 2018 International 49er and 49erFX Class European Championships shall be undertaken in three parts:

- 1. A self-declaration form to be completed by the sailors prior to arriving for pre-event equipment inspection
- 2. Specific measurement checks at pre-event equipment inspection
- 3. Post-race inspections

### **Self-Declaration Form**

The Self Declaration Measurement Form can be downloaded (and printed) from the Event and 49er Class Websites prior to arrival in Gdynia. Blank forms will not be accepted by the measurement team. Sailors are required to record the serial numbers of equipment to be used for the event on this form.

#### **Pre-Event Equipment Inspection**

Equipment inspection for all teams competing in the International 49*er* Class 2018 European Championship shall commence as follows:

- Thursday 5<sup>th</sup> July 0900 to 1800
- Friday 6<sup>th</sup> July 0900 to 1800
- Saturday 7<sup>th</sup> July 0900 to 1100 (late entries only)

PLEASE NOTE: No team shall be considered for Pre Event Equipment Inspection until the event entry fee has been paid in full and the Equipment Declaration Form has been completed where required by the team (Serial Numbers).

The Self Declaration Form shall be fully completed before entering the measurement area but leaving the following to be completed by the measurement team:

- Hull Weight
- Forestay Length

Following completion of the Self Declaration Form please proceed to the Pre Event Inspection Area with your completed Self Declaration Form, boat, sails, mast and forestay.

All teams are reminded that mainsails shall be presented with the correct country flag, country code and sail number in place. Sail numbers shall be the personal number issued by the ICA or last World Championship top 10 placing, in accordance with Class Rule A.11.1(b). Incorrect identification (sail number or national flag) will **NOT** be event approved. Please be aware teams may be asked to remove mainsail battens for checking compliance with Class Rule C.10.1(b).

Hulls shall be dry and drained of any internal water. Failure to comply will see the offending hull quarantined until such time its dryness satisfies the inspection team.





All equipment requiring a 9*er* Certified Equipment sticker as in accordance with the International 49*er*/49*er*FX class rules shall do so. Note: the gennaker pole sticker may be found on the inside of the spar at the aft end.

**<u>Remember</u>** – Please complete the equipment inspection form prior to arriving for inspection. Blank forms will not be accepted by the Equipment Inspection team meaning that a team may be relegated to the end of the timetable.

All competitors are reminded that in accordance with RRS 78.1 you are responsible for ensuring that your equipment is maintained in accordance with the current class rules.

## Items to be pre event inspected and event limited:

- Hull Weight Hulls shall be clean and dry (Refer to Class Rules)
- Forestay Shall be measured and event tagged
- Sails Shall be inspected and signed/stamped

Pre Event Equipment Inspection shall be by Country and shall be both 49er and 49erFX combined.

## Saturday 7 July 2018

Late entries and teams failing to comply with the above timetable will be inspected from 0900 hrs Saturday 7 July.





Once the above checks have been completed please proceed to Registration with your Event Self Declaration Compliance Form.

Failure to lodge the signed completed Self Declaration Form with the Event Registration may result in a penalty.

### **Post-Race Inspections**

For Post-Race checks, a number of boats shall be selected, based on the finishing positions for the last race of that day, for measurement compliance checks.

Selected boats **SHALL** proceed directly to the Measurement Area on returning to shore for a Measurement Compliance Check.

Items of Equipment used will be checked against the Self Declaration Form for Compliance and the Class Rules

Boats identified as not using Equipment as declared on the Self Declaration Form (or approved replacement equipment) shall be subject to protest by the Event Technical Committee, and may risk a penalty applied to all races sailed on that day as detailed in the Event Sailing Instructions.

#### Medal Race Inspections

Boats competing in the medal race shall be inspected by the Technical Committee before they depart for the race area. Competitors will be notified of the time and location of the inspections prior to the medal race day.

Failure to present your boat early for inspection will delay your departure to the race area as boats must be inspected before being allowed afloat.

The Event Equipment Inspection team looks forward to working with you to ensure a smooth transition through the Pre Event inspection process. Thank you.
